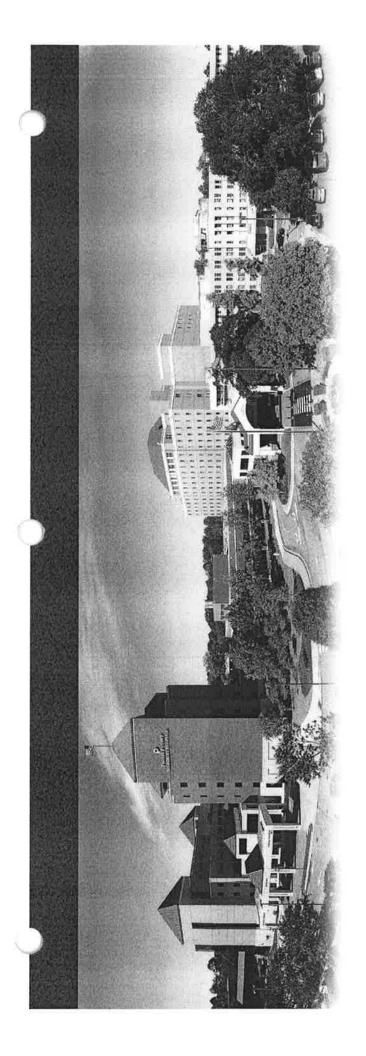

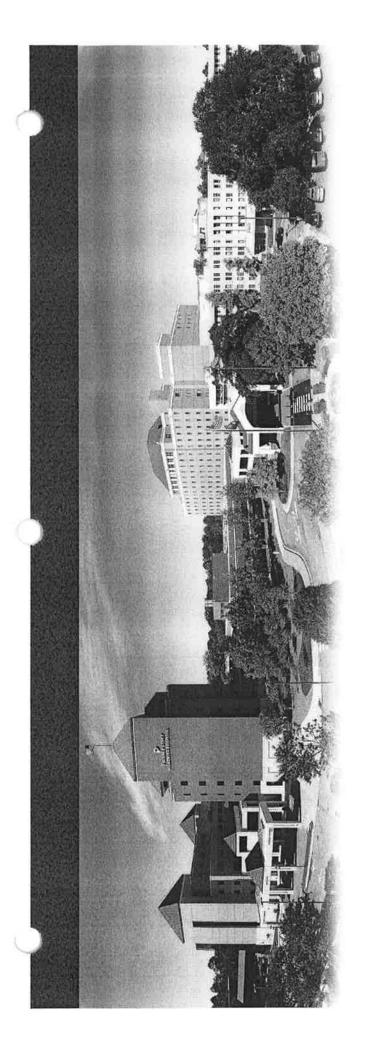

Ralph Rosenberg was born October 15, 1931, the only child of the late Joseph and Regina Rosenberg. He graduated from Albany High School in 1948 and furthered his education at Vanderbily University in Nashville, TN. Upon graduation from Vanderbilt University in 1952, he enlisted in the U.S. Army as a private. After three years of military service with the Army Security Agency in Europe, Rosenberg was honorably discharged with the rank of sergeant.

In 1955, after returning from military service, Rosenberg settled in Atlanta and remained there for 12 years during which time he worked in real estate, stock brokerage and retail with Rich's Inc. It was during those years that he met and married Pearl Goldstein Garber. In 1967, when his youngest son Robert was six months old, the family moved to Albany where Rosenberg entered the family retail business, Rosenberg Brothers. He remained with Rosenberg's for 25 years until the firm closed in 1992.



During his years with Rosenberg's, he carried on the family tradition of becoming involved with civic and community affairs. His contributions to Albany include treasurer and board member of the Albany Chamber of Commerce, board member of The Better Busineess Bureau, member of the Advisory Board of the Salvation Army, member of the Advisory Board, Chehaw Council Boy Scouts of America, Board of Trustees Albany Hebrew Congregation, member of both the downtown Albany and Albany Mall merchants associations. In addition, he serves as a board member of the Credit Bureau of Southwest Georgia, CBV Collections of Valdosta and for several years, Chairman of the Board of the Albany-Dougherty County Hospital Authority.

Rosenberg has three children, Suanne Mallenbaum of Scarsdale, N.Y., Richard Garber of Atlanta, Ga., and Robert Rosenberg who resides in Albany. Additionally, he has three grandchildren.

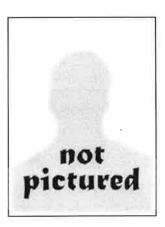
Rev. Eugene Sherman, Secretary Hospital Authority of Albany-Dougherty County

Appointed: December 2003 / Term Ends: December 2013

Dr. Eugene Sherman has an extensive University career with 35 years as Head Professor of Sociology at Albany State University, where he also held several administrative posts. Professor Sherman retired from the University as Emeritus Professor in 2002. Additionally, he is the founding pastor of Institutional First Baptist Church in Albany. He holds the Doctor of Sacred Theology Degree from Bethany Theological Seminary in Dothan, Ala.

Dr. Sherman earned his bachelor's degree from Fort Valley State College and his master's degree from Southern Illinois, where he studied sociology, particularly family, history, and gerontology. His M.A. thesis was the nation's first gerontological study of the African-American population. He also earned a Doctor of Philosophy from Purdue University.

He was married to the late Dr. Dolores E. Sherman.

Dr. John Inman, Jr. a diplomate of the American Board of Obstetrics, graduated from Emory University School of Medicine, in Atlanta in 1945.

Dr. Inman completed an internship and surgical residency at St. Joseph Hospital, Lexington, Kentucky and a residency in obstetrics and gynecology at Crawford Long Hospital in Atlanta.

Inman returned to his hometown of Albany to establish his own practice in the early 1950s, a time when fathers-to-be were not even permitted in the delivery room. Since then, Inman has been recognized as a Diplomat of the American Board of Obstetrics and Gynecology, is a past chairman of the Georgia Section of the American College of Obstetrics and Gynecology, past president of the Georgia Obstetricians and Gynecologists Society and past vice president of the South Atlantic Association of Obstetrics and Gynecology. He is also a founding member of the National Council of Emory University School of Medicine.



Dr. Inman is a former vice president and director of the Dougherty County Kiwanis club, director of Security Bank & Trust Company in Albany. The father of two and grandfather of four, Inman is also on the Board of Trustees of the YMCA, Albany.

Dr. Inman currently practices at OB-GYN Associates of Albany located on Meredyth Drive.

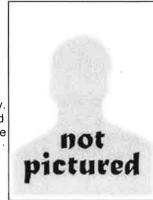
Hayes served three years active duty and three years as a reservist in the U.S Army. He is married to Sabrina Owens-Hayes and they have one son, Jaelon.

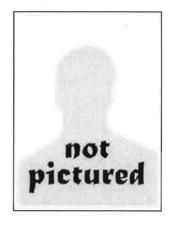

 manufacturing facility.

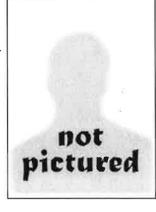
Ghiglieri retired from Procter and Gamble in 2005.

Steven Wolinsky, D.O. Hospital Authority of Albany-Dougherty County

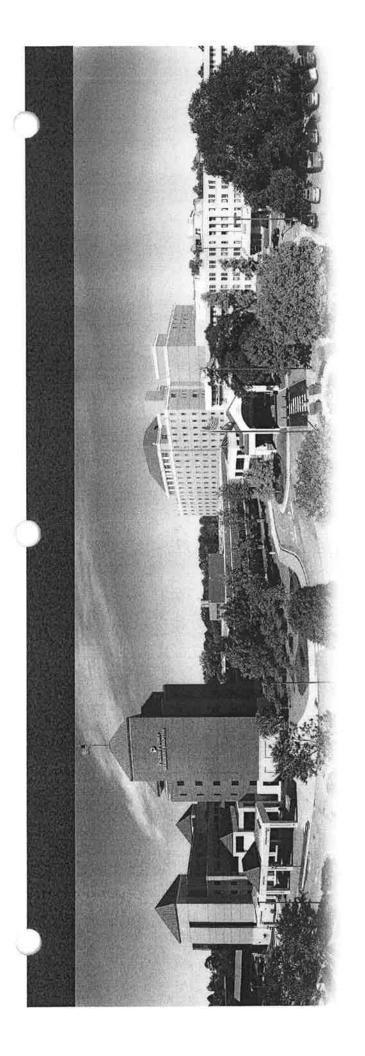

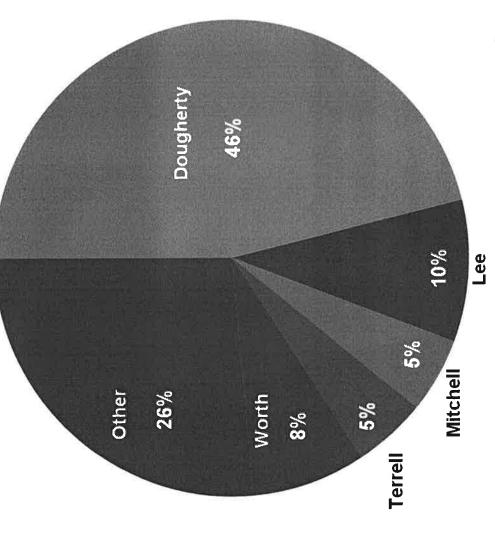

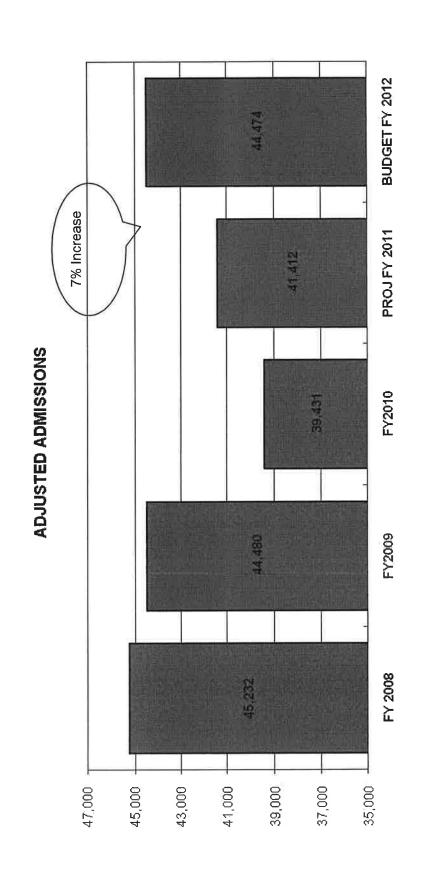
